AND TO: CGS Asset Management Ltd. (the “**Manager**”)

The undersigned (the “**Subscriber**”) hereby acknowledges receipt of the confidential offering memorandum dated February 12, 2010 (the “**Offering Memorandum**”) relating to an offering of redeemable, retractable, non-voting participating Class A Shares of two series: Series A shares and Series F shares (collectively, the “**Shares**”) of the Company, a corporation incorporated under the federal laws of Canada. The Subscriber acknowledges that this subscription agreement (the “**Subscription Agreement**”) is not binding on the Company until accepted, in whole or in part, by the Manager on behalf of the Company, in its sole discretion.

SHARE DESCRIPTION

Class A Shares are available for purchase by investors. There are 2 types of Class A Shares available for purchase:

- i) **Series A:** 2.00% management fee per annum; 0.40% service fee to Investment Advisors per annum paid out of the management fee (paid quarterly); and a performance fee equal to 20% of the investment returns in excess of a 6% annualized hurdle.
- ii) **Series F (Fee Based Accounts):** 1.60% management fee per annum; no service fee paid to Investment Advisors; and a performance fee equal to 20% of the investment returns in excess of a 6% annualized hurdle.

The undersigned Subscriber hereby irrevocably subscribes for and agrees to purchase from the Company that dollar value of Class A Shares (Series A or F) of the Company (the “**Purchased Shares**”) set out below equal to the net asset value per Purchased Share as of the applicable Valuation Date (as defined below; the aggregate dollar value of such Purchased Shares is the “**Subscription Price**”).

1. Amount Payable

A "**Valuation Date**" is the last Business Day (any day except Saturday, Sunday, a statutory holiday in Toronto, Ontario or any other day on which the Toronto Stock Exchange is not open for trading) of each week. Fully executed and completed Subscription Agreements and cleared funds satisfying the Subscription Price for the Purchase Shares received by 4:00 PM (ET) on the Valuation Date will be accepted on the Valuation Date in such week. Subscriptions received after that time will be accepted on the next Valuation Date. Shares will be deemed to be issued on the next Business Day based on the NAV per Share on such Valuation Date.

2. Acceptance of Subscription

The Subscriber acknowledges and agrees that participation in the Company is subject to the acceptance of this subscription by the Manager and payment of the Subscription Price. This Subscription Agreement and the Subscription Price or any portion thereof will be returned forthwith to the Subscriber, without interest or deduction, at the address indicated on page 2 hereof if this subscription or any part of this subscription is not accepted.

3. No Share Certificates

- (a) The Subscriber will not be entitled to receive a share certificate or other instrument representing the Purchased Shares or evidencing beneficial ownership of the Purchased Shares from the Company, the Manager, or any other person and the ownership of Shares shall be evidenced solely and conclusively by the register maintained by the Company. However, on any purchase or retraction of Shares, the Manager shall issue written confirmation indicating the nature of the transaction effected by the Subscriber and the number of Shares held by such Subscriber after such transaction.
- (b) Under Applicable Securities Laws (as defined below), the Company must notify you that if a share certificate was issued, it would bear a legend substantially in the following form: "Unless permitted under securities legislation, the holder of this security must not trade the security before the date that is 4 months and a day after the later of (i) the distribution date, and (ii) the date the issuer became a reporting issuer in any province or territory."

4. Conditions of Closing

As used in this Subscription Agreement, “**Applicable Securities Laws**” means any and all securities laws including, statutes, rules, regulations, by-laws, policies, guidelines, orders, decisions, rulings and awards, applicable in the jurisdictions in which the Shares will be offered, sold and issued;

5. Prospectus Exemptions, Resale and Transfer Restrictions

The Subscriber, on its own behalf and on behalf of any disclosed principal for whom the Subscriber is contracting under this Subscription Agreement (a “**Disclosed Beneficial Subscriber**”) acknowledges and agrees that:

- (a) the decision to enter into this Subscription Agreement and to purchase the Purchased Shares has not been based upon any verbal or written representation or documentation as to fact or otherwise made by or on behalf of the Company, its affiliates or the Company except as set forth in the Offering Memorandum (and not in any preliminary or earlier draft thereof or in any confidential information memorandum);
- (b) the Subscriber has read and fully understands the Offering Memorandum and has had an opportunity to ask and have answered questions with respect to the Company;
- (c) the sale and delivery of the Purchased Shares to the Subscriber (and any Disclosed Beneficial Subscriber) is conditional upon such sale being exempt from the prospectus filing requirements of any applicable statute relating to the sale of the Purchased Shares;

- (a) an investment in Shares is not without risk and the Subscriber (and any Disclosed Beneficial Subscriber) may lose his, her or its entire investment;

- (g) if the Subscriber is an individual, the Subscriber has obtained the age of majority and is legally competent to execute this Subscription Agreement and to take all actions required pursuant hereto;
- (h) the Subscriber has obtained independent legal and tax advice as to the Subscriber's liabilities under this Subscription Agreement, and acknowledges that the relevant provisions of the *Income Tax Act* (Canada) (the "**Tax Act**") and related statutes are complex and that the Subscriber has taken such steps as the Subscriber considers necessary to ensure that the Subscriber understands the meaning and effect of such representations, warranties and indemnities;
- (i) the Subscriber (or any Disclosed Beneficial Subscriber) has full power and authority to execute and deliver this Subscription Agreement and all other agreements, instruments and other documents contemplated hereby or thereby and to take all other actions required by this Subscription Agreement and has obtained all necessary approvals and authorizations in connection therewith;
- (j) the Subscriber has read the Offering Memorandum and is aware of the characteristics of the Purchased Shares and of their speculative nature;
- (k) the Subscriber (and any Disclosed Beneficial Subscriber) has been independently advised as to and is aware of the resale restrictions under Applicable Securities Laws with respect to the Purchased Shares and acknowledges receipt of a written notice of the legend restriction notation applicable to the resale of the Purchased Shares as set forth in Section 3(b);
- (l) the Subscriber (and any Disclosed Beneficial Subscriber) is not (i) a "non-resident" of Canada for the purposes of the Tax Act, (ii) a "non-Canadian" within the meaning of the *Investment Canada Act* or (iii) a partnership and that he, she or it will maintain such status during such time as Purchased Shares are held by him or her;
- (m) the Subscriber (or any Disclosed Beneficial Subscriber) is not a "financial institution" as that term is defined in subsection 142.2(1) of the Tax Act unless such investor has provided written notice to the contrary to the Manager prior to the date of acceptance of the investor's subscription for Purchased Shares. An investor who is not an individual may be obliged to provide the Manager with a declaration that it is not a "financial institution" as that term is defined in subsection 142.2(1) of the Tax Act;
- (n) the Subscriber (and any Disclosed Beneficial Subscriber) is not a "U.S. Person" (as that term is defined in Regulation S promulgated under the U.S. Securities Act, which definition includes, but is not limited to, an individual resident in the United States, an estate or trust of which any executor or administrator or trustee, respectively, is a U.S. Person and any partnership or company organized or incorporated under the laws of the United States) and is not acquiring the Securities for the account of or benefit of a U.S. Person or a person in the United States;
- (o) the Subscriber represents and warrants that the Subscriber (and any Disclosed Beneficial Subscriber) is not named on or blocked by any of the following lists (the "**Prohibited Lists**") promulgated by the Department of

- (ii) the List of Names subject to the Regulations Implementing the United Nations Resolutions on the Suppression of Terrorism; (found at OSFI website at http://www.osfi-bsif.gc.ca/osfi/index_e.aspx?DetailID=525); and
- (iii) the List of Names subject to the United Nations Al-Qaida and Taliban Regulations (found at OSFI website at http://www.osfi-bsif.gc.ca/osfi/index_e.aspx?DetailID=525).

The Subscriber acknowledges and agrees that the Manager has provided herein certain lists adopted or published by applicable governmental authorities for the convenience of the Subscriber and that because these lists are subject to change from time to time, it is the responsibility of the Subscriber to ensure that the lists are current as of the time this Subscription Agreement is executed and that each representation made by the Subscriber is true and correct as of the date of the Subscription Agreement.

- (p) to the best of the Subscriber's knowledge the money that the Subscriber seeks to invest is not derived from any criminal enterprise or proceeds of crime for the purposes of the *Proceeds of Crime (Money Laundering) Act* (Canada).
- (q) the Subscriber agrees to provide to the Manager or the Administrator (as the case may be) such additional information as the Manager or the Administrator (as the case may be) may request, and to take such other reasonable actions on request as may be advisable in the reasonable judgment of the Manager or the Administrator (as the case may be) or its agents or service providers, to enable the Manager to satisfy its anti-money laundering and anti-terrorist financing responsibilities.
- (r) the Subscriber acknowledges and agrees that the Subscriber may encounter delays in effecting redemptions or in receiving distributions or other payments from the Company, and may be required to redeem from the Company, if information requested by the Manager, the Company or the Administrator (as the case may be) or any of the Company's other agents or service providers is not provided in a timely manner. - (u) the Subscriber acknowledges that, if the Subscriber is or becomes named on or blocked by any Prohibited List, or if the Manager, the Company or the Administrator (as the case may be) is otherwise required by law, the Manager, the Company or the Administrator (as the case may be) may freeze its investment, by prohibiting additional investments, declining redemption requests or segregating assets constituting the investment in accordance with applicable regulations, or the Subscriber may be required to redeem from the Company. In

- (w) except as required by applicable laws, the Subscriber agrees to keep confidential all information provided to the Subscriber relating to the business and affairs of the Company and not to distribute or otherwise make available any such information to any other person or otherwise exploit any such information.

By completing this Subscription Agreement, the Subscriber authorizes the indirect collection of this information by each applicable securities regulatory authority or regulator and acknowledges that such information may be made available to the public under applicable securities legislation.

9. Waiver of Withdrawal Right

The Subscriber, and each Disclosed Beneficial Subscriber, if any, for whom the Subscriber is acting, hereby waives and releases the Manager and the Company from all rights of withdrawal to which it might otherwise be entitled under Applicable Securities Laws, to the fullest extent permitted by law.

10. Subscriber's Rights of Action

The Subscriber shall have such rights of action against the Company as is described in the Offering Memorandum under "What are Your Legal Rights?".

11. Beneficial Subscribers

Whether or not explicitly stated in this Subscription Agreement, any acknowledgement, representation, warranty, covenant or agreement made by the Subscriber in this Subscription Agreement, including any schedules attached hereto, will be treated as if made by the Disclosed Beneficial Subscriber, if any.

12. Governing Law

This Subscription Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta and the federal laws of Canada applicable therein. The Subscriber, on its own behalf and (if applicable) on behalf of others for whom it is contracting hereunder, hereby irrevocably attorns to the non-exclusive jurisdiction of the courts of the Province of Alberta with respect to any matters arising out of this Subscription Agreement.

13. Survival

22. Language of Documents

SCHEDULE “A”
STATEMENT OF POLICIES REGARDING SECURITIES OF RELATED
AND CONNECTED ISSUERS AND RELATED REGISTRANTS

National Instrument 31-103 *Registration Requirements and Exemptions* (“NI 31-103”) requires registered firms to identify and respond to existing material conflicts of interest and material conflicts of interest that can reasonably be expected to arise between the registered firm and its client. Potentially, a conflict of interest arises under either of the following situations: (i) a registered firm trades in or advises with respect to its own securities or securities in certain other issuers to which it, or certain other parties related to it, are related or connected; and (ii) a registered firm has a director, officer or principal shareholder that is a director, officer or principal shareholder of another registrant.

Statement of Policies Concerning Related and Connected Issuers

CGS Asset Management Ltd. (“**CGS**”) is registered as an adviser under the *Securities Act* (Ontario) and under the *Securities Act* (Alberta) in the category of portfolio manager.

In performing its services, CGS may from time to time advise on or trade in securities of one of its related, connected or associated issuers. The investment funds managed by CGS may invest in entities related to CGS or purchase a security of an issuer in which a responsible person or an associate of a responsible person is a partner, officer or director.

“**connected issuer**” means, in respect of CGS, an issuer that has, or any related issuer of which has, any indebtedness to, or other relationship with, (i) CGS, (ii) related issuer of CGS, (iii) director, officer or partner of CGS or (iv) director, officer or partner of a related issuer of CGS, that, in connection with a distribution of securities of the issuer, is material to a prospective purchaser of the securities. Accordingly, an issuer is “connected” to CGS if, due to indebtedness or other relationships, a prospective purchaser of securities of the connected issuer might question CGS independence from the issuer.

“**related issuer**” means, in respect of CGS, an issuer of securities over which CGS exercises a controlling influence (for example, through the ownership of, or direction or control over voting securities) or an issuer of securities that exercises a controlling influence over CGS. In this context, the term “influence” means having the power, directly or indirectly, to exercise a controlling influence over the management and policies of the company, whether alone or in combination with one or more other persons or companies.

“**responsible person**” means, for a registered adviser, (a) the adviser, (b) a partner, director or officer of the adviser, and (c) each of the following who has access to, or participates in formulating, an investment decision made on behalf of a client of the adviser or advice to be given to a client of the adviser: (i) an employee or agent of the adviser; (ii) an affiliate of the adviser; and (iii) a partner, director, officer, employee or agent of an affiliate of the adviser.
